AGREEMENT

Applicant agrees that JDR Microdevices in its sole discretion may grant privileges to applicant to make deferred payment for products purchased from JDR MICRODEVICES. The deferred payment privilege, if and when granted, shall be subject to and in consideration of the terms and conditions which follow:

The application is not for customers who intend to use products purchased for personal, family, or household purposes. By completing this application, the applicant represents to JDR MICRODEVICES that applicant will not use the products for those purposes.

This is not an application for the extension of credit. If JDR MICRODEVICES grants applicant the privilege of making deferred payment, it will sell and deliver products without payment in advance.

Applicant authorizes JDR MICRODEVICES to make a credit investigation of application and to contact applicant's bank and trade references. Applicant authorizes said references to release credit information to JDR MICRODEVICES.

JDR MICRODEVICES shall have the right to terminate deferred payment privileges at any time with or without notice to customer.

Payment of amounts due JDR MICRODEVICES for products purchased shall be made not later than the due date and in accordance with the terms indicated on each invoice to customer. If payment terms or due date is not indicated, payment shall be made within thirty days of customer's receipt of product. In no event shall JDR MICRODEVICES accept nor shall customer be entitled to make payment in more than three installments, and in no event is the sale a credit sale.

If a customer fails to make payment when due, customer agrees to pay in addition a late payment charge on the amount due and owing to JDR MICRODEVICES. It is agreed that the actual loss to JDR MICRODEVICES on account of late payment would be extremely difficult and impractical to determine and that fair compensation to JDR MICRODEVICES for such failure shall be a late payment charge of 1 1/2 percent per month on the balance due and owing (or the highest rate allowed by law if that is less than 1 1/2 percent per month).

If JDR MICRODEVICES resorts to legal action or other collection proceedings to collect any amount due and owing from customer, all reasonable costs, collection charges, and attorneys fees shall be paid by the customer.

The terms and conditions of sale shall include those set forth above and those contained in the JDR MICRODEVICES Catalogue and Customer Purchase Order.
